CLUB BY LAWS

NEW MEMBERS

- BEFORE ANYONE BECOMES A MEMBER OF THE “PUSH RODS” ROD AND CUSTOM CAR CLUB, THE INDIVIDUAL SHALL BE INTRODUCED TO THE MEMBERSHIP AT A REGULAR CLUB MEETING.
- THE INDIVIDUAL SHALL STATE TO THE MEMBERSHIP AND MEMBERSHIP COMMITTEE THEIR INTEREST IN THE CLUB AND THEIR VEHICLE(S) ETC.
- THE INDIVIDUAL(S) WILL AT THIS POINT BECOME A PROSPECT.
- COMMITTEE WILL READ TO THE PROSPECT(S) THE RULES AND BY LAWS OF THE “PUSH RODS” ROD AND CUSTOM CAR CLUB.
- THE PROSPECT(S) WILL THEN FILL OUT THE “PUSH RODS” ROD AND CUSTOM CAR CLUB MEMBERSHIP APPLICATION FORM.
- THE PROSPECT(S) MEMBERSHIP WILL BE VOTED BY THE MAJORITY VOTES OF THE “PUSH RODS” ROD AND CUSTOM CAR CLUB ACTIVE MEMBERS PRESENT AT THE REGULAR MEETING.
- VOTING SHALL BE BY SECRET BALLOT.
- AFTER THE VOTING IS COMPLETE THE PROSPECT(S) WILL EITHER BE ACCEPTED OR DENIED.
- IF ACCEPTED THE PROSPECT(S) WILL BECOME A “PROSPECT MEMBER” AND WILL BE ON PROBATION FOR A PERIOD OF NINETY DAYS.
- MEMBERSHIP COMMITTEE WILL REVIEW THE “PROSPECT MEMBER(S)” AFTER THE THIRD MEETING.
- ON THE FORTH MEETING THE “PROSPECT MEMBER(S)” WILL BECOME A FULL CLUB MEMBER WITH THE RIGHT TO VOTE, RECEIVE A JACKET, TEE SHIRT, AND PLAQUE (WHEN AVAILABLE).
- NEW MEMBERS SHALL THEN PAY MEMBERSHIP FEE OF \$50.00. MEMBERSHIP FEE SHALL INCLUDE ALL ABOVE ITEMS.
- NO ONE SHALL MAKE ANY PURCHASES FOR THE “PUSH RODS” ROD AND CUSTOM CAR CLUB WITHOUT THE APPROVAL OF THE FULL MEMBERSHIP COMMITTEE BOARD. THE FULL MEMBERSHIP COMMITTEE BOARD INCLUDES THE PRESIDENT, VICE PRESIDENT, SECRETARY, TREASURER, & SGT. AT ARMS.
