- CLUB COLORS SHALL BE WORN AT ALL CLUB MEETINGS AND FUNCTIONS.
- PERIODIC INSPECTIONS FOR PROGRESS OF UNFINISHED VEHICLES.
(AN UNFINISHED VEHICLE IS A VEHICLE THAT IS NOT DRIVABLE)
- PUSHRODS MEMBERS CANNOT BE A MEMBER OF ANOTHER CAR CLUB.
- CLUB DUES ARE \$5.00 PER MONTH AND DUE DURING MONTHLY CLUB MEETINGS.
- CONTACT CLUB PRESIDENT OR VICE PRESIDENT IF YOU PLAN TO MISS CLUB MEETINGS.
- DURING OUR DECEMBER ANNUAL ANNIVERSARY CLUB MEETING, MEMBERS WILL VOTE TO ELECT COMMITTEE OFFICERS (*PRESIDENT, VICE PRESIDENT, SECRETARY, TREASURER, SGT. AT ARMS*). THE ELECTED OFFICERS SHALL IMMEDIATELY TAKE ON ALL DUTIES AND RESPONSIBILITIES FOR WHICH THEY WERE ELECTED FOR AFTER THE MEETING IS ADJOURNED.
- ONLY ACTIVE MEMBERS HAVE A RIGHT TO VOTE.
- ANY MEMBER SEEKING INTEREST IN COMMITTEE OFFICER POSITIONS MUST NOTIFY THE COMMITTEE PRIOR TO THE DECEMBER ANNUAL MEETING.
- ANY CHANGES IN CLUB RULES AND BY-LAWS ARE TO BE MADE AT CLUB MEETINGS, IN THE PRESENCE OF MEMBERS, WITH THE MAJORITY RULING.
- THE TREASURER IS TO STATE CURRENT DOLLAR AMOUNT OF FUNDS AVAILABLE DURING MONTHLY MEETINGS.
- FAMILY MEMBERS (*SPOUSES, SIBLINGS, ETC..*) ARE WELCOME TO ALL CLUB MEETINGS.
